

## WTR Ranks Wanhuida in 2024

In the 2024 edition of the World Trademark Review 1000 - The World's Leading Trademark Professionals, which is released on 7<sup>th</sup> February 2024, Wanhuida Intellectual Property has topped both litigation and prosecution rankings for yet another year. The firm is rated in the Gold Band as a first-tier PRC firm for both "*Prosecution and Strategy*" and "*Enforcement and Litigation*" category.

Firms qualify for a listing on the basis of their depth of expertise, market presence and the level of work on which they are typically instructed. The results are presented in bands – gold, silver and bronze – to reflect the reputations of teams and professionals relative to their peers in the field.
