The firm has secured two top-tier rankings on the prestigious platform, across "Trade mark prosecution – domestic firms" and "Trade mark disputes – domestic firms", which affirms its status as a leader in the PRC legal market.

The firm has been a perennial sitting comfortably at the apex of the Chinese trademark market since 2011.
